

Updates from the States

Thus far in 2025, two states have adopted the ASLP-IC legislation: Arizona and Nevada, bringing the total number of jurisdictions to 37. Legislation remains active in several additional states. Legal Corner

We are entering an exciting phase of compact development as we prepare to operationalize the ASLP-IC early this fall. Though the ability of each member state to onboard presently is varied, we must stay focused on our legal duty to implement the ASLP-IC according to its terms in accordance with legislative directive through enactment of the ASLP-IC in each of our member states. The best way to comply with this requirement is to ensure that your state is moving swiftly through the member state onboarding checklist. (<https://aslpcompact.com/wp-content/uploads/2025/07/State-Onboarding-for-CompactConnect-July-25.pdf>) The recent promulgation of the Rule on Implementation of Criminal Background Check Requirement (<https://aslpcompact.com/wp-content/uploads/2025/07/ASLP-IC-Rule-on-Implementation-of-Criminal-Background-Check-Requirement-CURRENT.pdf>) enables member states to onboard without an FBI CBC in place, but only if they meet all other requirements of the rule and recognize that an FBI CBC must be required of all compact participants once a member state is able to conduct the FBI CBC. Additionally, we have heard concern in recent member state onboarding meetings that certain reporting requirements cannot be met due to member state law preventing the reporting of that information. Section 14.B gives member states the authority they need to provide information required by ASLP-IC law and rule as it specifically states that "All laws in a member state in conflict with the Compact are superseded to the extent of the conflict".

As your general counsel, I remain available to answer your questions and provide the support you need to move confidently toward implementation in your state. I deeply appreciate all the work member states and delegates have done thus far, and I look forward to assisting you as we move forward together in providing much needed greater access to safe and competent care.

I am excited to announce we have completed our last major feature in CompactConnect - adverse actions. For the next few weeks, the remaining work will be focused on minor tweaks to ensure the system is ready to go live. Our biggest hurdle at this time is helping states through the onboarding process. We are happy to have 1:1 meetings with state administrators and IT staff to walk you through the system. For states that want to be a part of the initial launch, we request that your data is tested in the CompactConnect Beta Environment by August 31.

News from the Rules Committee

Since the last newsletter, the Committee has worked on the following rules and bylaws, which were approved at the Commission's Special Meeting on July 1, 2024 and June 30, 2025. The Committee has also proposed a rule amendment for approval at the Commission's annual meeting scheduled for September 20, 2025.

Bylaws Approved at the Special Commission Meeting on July 1, 2024

- Amendments to the Commission bylaws included general clean-up of language for clarity and organization. Other amendments included filling vacant positions for the additional five delegates who are either a public member or board administrator.

Rules Approved at the Special Commission Meeting on June 20, 2025

- New rule on Fees
 - Sets the Commission administrative fee at \$50.00 to be paid by the licensee to the Commission for each state in which a Privilege to Practice that is requested in addition to each individual State's Fee.
 - Member States may establish their State Fee in accordance with the Member State's required processes to be paid by the licensee to the Commission. The Commission shall remit to the Member State 100% of the State Fee.
- Amended ASLP-IC Rule on Implementation of Criminal Background Check Requirement
 - Clarified that the Home state must implement or utilize procedures to obtain the FBI and Home state's criminal records, for applicants within their Home state who are applying for their initial, e.g., very first time, privilege to practice in one or more states under the ASLP-IC.
 - Amended the timeframe for member states to implement criminal background checks and exceptions for legal impossibility for states meeting the criminal background check requirement.

Rules Proposed for the Commission Annual Business Meeting on September 20, 2025

- Proposed amendment to the Rule on Dataset reporting requirements
 - Proposed amendment to the dataset reporting requirements to allow member states to report National Practitioner Identifier as accommodated by CompactConnect


Frequently Asked Questions (FAQ)
